1. **Course Duration.** The duration of the course is three years (six semesters). Course affiliated to Bengaluru North University.
2. **Date of Reporting for Admission and Action to be Taken.** You are required to report to the Principal/Registrar of this Institute on 01 Jul 2019 at 10.00 AM along with the following certificates in original and two sets of Xerox copies (10<sup>th</sup> 11<sup>th</sup> & 12<sup>th</sup> Passing Marks Cards, TC, Character & Migration Certificate) ie. one set of Xerox copy to be handed over to the office and one set of Xerox copy to be retained with the student during the whole course. Xerox copy to be done from home station itself as institute will not provide Xerox copies while joining the Institute.

3. **Hostel Accommodation and Messing Charges per Annum.** Accommodation will be made available on Campus for boys and girls separately. Students are required to send a Demand Draft/RTGS/NEFT for Hostel Accommodation in favour of "**Army Institute of Fashion and Design**", payable at Bangalore for Rs.38,421/- (less advance Rs 5,000/- if paid in advance as Hostel Registration fee) and Messing charges Rs 42,966/- (subject to changes depending on new contract) for ten months ie. less two months semester vacation period to be paid on or before 20 Jun 2019. All first year Army wards will stay compulsorily in the Campus Hostel.

4. **Annual Institute Fee.** The students have to pay Annual Institute fee of Rs 1,92,814/- for Army students (less advance of Rs 10,000/- if paid in advance as Institute Registration fee) and Rs 2,22,207/- for Karnataka civilian students (less advance of Rs 10,000/- if paid in advance as Institute Registration fee) (refer Para 12 of E-Prospectus for fee details) to be paid on or before 20 Jun 2019 to the Institute through Demand Draft/NEFT/RTGS. Admission to the Institute will not be granted without paying full payment of fees mentioned below. One DD/RTGS/NEFT can be made for total fees including one time charge, annual institute fee, hostel and messing charges in favour of "**Army Institute of Fashion and Design**" payable at Bangalore. (Total Fee – Rs 1,92,814/- for Army wards and Rs 2,22,207/- for Karnataka Civilians).

6. **Inability to Report on Due Date for the Course**. In case due to unavoidable circumstances, you are not in a position to report to this Institute on due date i.e., on 01 Jul 2019, your parent/guardian/representative should report to this Institute with necessary documents/certificates and take all decisions pertaining to admission. Performa for letter of authority is attached as Appendix 'A' to the instructions. If you or your parent/ guardian/representative do not report to this Institute on the due date, your candidature will be cancelled and no representation will be entertained in this regard. Requests for extension of joining date will not be accepted under any circumstances/reasons whatsoever. However, the candidates, who are deputing their parents/guardians/representatives are required to report to this Institute on 01 Jul 2019 and the candidate should report to the Institute on 02 Jul 2019 without fail.

7. **Discipline**. You are expected to conduct yourself strictly as per norms and code of conduct of this Institution. In case you are found lacking in discipline or fail to abide by the rules and regulations of the Institute, action will be taken as per the AWES Rules.

8. **Clothing**. Bangalore has moderate climate round the year. You are, therefore, not required to bring heavy winter clothing. However students staying in the hostel are required to bring the following items :-

**Note 1** :- Students will be provided with Steel Almirah, Table, Chair, Single Cot with Mattress & Pillow. Other minor items can be procured from the local market as per the requirement of the student.

**Note 2** :- **Dress Code and Mobile** : Institute will provide uniform to the students. All students are required to wear institute uniform everyday from Monday to Saturday except Thursday. Blazer with uniform will be worn on Wednesday. No slippers/sandals permitted in class rooms/offices/college premises. Details of the other dress code will be provided during admission. Use of mobile Phone inside the campus is banned.

9. **Valuables.** You are advised not to bring jewellery or other valuable items along with you. Use of mobile phone inside the Campus is strictly prohibited.

10. **Amount for Immediate Personal Expenditure.** It will be the responsibility of the students to keep their cash in Bank. The students are, therefore, advised not to bring large sums of money except in the form of bank drafts.

11. **Banking Facilities.** There are three nationalized banks available within three KMs radius from the institute. Students can open their new Bank Account in their own interest. However, the parents are advised to open Bank Account in the name of their ward preferably in their home town which students can operate through ATM.

12. **Local Guardians.** The students who are admitted to Hostels will be allowed to visit only their local guardian residing in Bangalore during weekends/gazetted holidays as per rules. For this purpose, you are required to bring a letter of consent in duplicate, duly signed by your parent /guardian giving address of the local guardian. You may note that one local guardian is permitted. The Performa to be completed in duplicate by the parent of the students is given in Appendix 'B' attached. The Performa should be completed and handed over to the Institute on the day of joining.

13. **Boarding and Lodging Arrangement Till Admitted to the Institute / Hostel.** You are advised to make your own arrangements for yourself and your parents/guardian on arrival at Bangalore till you are finally admitted to the Institute/Hostel. 15. Please note that the admission to this Institute is provisional, subject to your fulfilling the eligibility conditions for admission approval by Bangalore University.

16. **Ragging.** Instructions received from AWES, AG's Branch, New Delhi vide their letter No B/45728/WAT/AWES dated 06 Apr 2009. The instructions regarding ragging are as follows :-

(a) Ragging is banned in educational institutions and hostel as per Hon'ble Supreme Court orders. Anyone indulging in such acts shall be subjected to punishment by a Court of Law/concerned authorities.

(b) "Ragging means causing, inducing, compelling or forcing a student, whether by way of a practical joke or otherwise, to do any act which detracts from human dignity or violates his persons or exposes him to ridicule or to for bear from doing any lawful act, by intimidating, wrongfully restraining, wrongfully confining or injuring him or by using criminal force on him or by holding out to him any threat of such intimidation, wrongful restraint, wrongful confinement, injuring or the use of criminal force".
