1. Bidder(s) can inspect the articles / items between 10-00 A.M. To 04-30 P.M. at Campus of Army Institute of Fashion and Design from 29 Nov 2017 to 08 Dec 2017 to ascertain the conditions, quality etc of the articles / items and satisfy themselves before submitting their offer by the date and time specified.
2. The intending bidders have to deposit EMD of Rs. 5000/- by way Demand Draft in favour of Army Institute of Fashion & Design payable at Bangalore and obtain the bid form at the time of inspecting of the items.
3. The intending bidders have to remit Application fee Rs.500/- (Non refundable) by the way of Demand Draft in favour of "Army Institute of Fashion & Design payable at bangalore
4. After inspection of items bidder should quote the price or an amount which he is ready to pay for the scrap offered for sale in a sealed bid.
5. Bid should be signed by bidder(s) himself / themselves or a person duly authorized in his behalf
6. Bid forms are not transferable.
7. The EMD of unsuccessful bidder will be refunded.
8. Tax shall be paid by the successful bidder, (if any).
9. All articles / items will be sold on "AS IS WHERE IS BASIS" (Lot wise) will be deemed to have been on the clean understanding that they have satisfied themselves full in regard to the conditions, quality and quantity of the articles / items proposed through closed bid.
10. The successful bidder will be required to make full payment of bid by way of Demand Draft / Banker's Cheque in favour of "Army Institute of Fashion & Design payable at Bangalore within 10 days after the finalization of the bid.
